4. Copy of Land Title Certificate not attached.
5. Fixed deposit receipt in original for Rs. 5.00 lakhs for a period of 5 years issued from a Nationalised Bank towards Endowment Fund not submitted.


6. Fixed deposit receipt in original for Rs. 3.00 lakhs for a period of 5 years issued from a Nationalised Bank towards Reserve Fund not submitted.
7. A Sworn Affidavit on Rs. 100/- stamp paper duly attested by Notary Not-submitted / submitted but matter is not as per regulations. (Copy Enclosed)

The Institution must have at least 2500 sq. mts. land whereupon built-in area consisting of classrooms etc. shall not be less than 1500 sq. mts.

Space in each instructional room shall be 10 sq. ft. per students for B.Ed., M.Ed and D.Ed. courses.

You may avail the statutory time-limit of 90 days to remove the deficiencies but it must be understood that the date of removal of all the date of receipt of your application.
